

# REGISTRATION INFORMATION

## 2010 Annual Convention & Exposition

**Registration Deadline: April 23, 2010**

**Registrations received after April 23, 2010, will be treated as walk-ins onsite.**

### Who Can Attend?

Attendance is limited to **Association-affiliated credit unions**. Association membership fee must be paid prior to registration. Each credit union is entitled to one delegate.

### How Much Does It Cost?

The **Conferee Fee** includes admission to all non-ticketed events at the Annual Convention & Exposition:

#### Early-Bird Registration

**(Payment Received by March 26, 2010):**

- **Credit unions under \$20 million** — Registration is \$150 per person.
- **Credit unions over \$20 million** — Registration is \$275 per person.
- **Discount for 5 or more registrants** — \$25 per conferee (*applies to credit unions over \$20 million only*).

#### Payment Received after March 26, 2010:

- **Credit unions under \$20 million** — Registration is \$200 per person.
- **Credit unions over \$20 million** — Registration is \$350 per person.
- **Discount for 5 or more registrants** — \$25 per conferee (*applies to credit unions over \$20 million only*).

For each paid conferee, one spouse/guest can be registered. The **Spouse/Guest Registration Fee** of \$75 per person includes admission to the Exposition, Continental Breakfast, and Youth Ambassador Contest.

### All convention attendees must be registered.

The Sunday afternoon Business Session is open to all Association-affiliated credit unions.

### Special Ticket Events

Tickets are required for the Pennsylvania Credit Union Foundation (PACUF) Breakfast. Your seating assignment card is required for the Banquet and Entertainment. Seating for the banquet is reserved on a first-come, first-served basis.

### Special Offer – CU Young Professionals

With each two (2) paid conferee registrations, your credit union receives one (1) free registration for a credit union young professional under age 35. There is a fee for the PACUF Breakfast and for the Banquet & Entertainment if the registrants choose to attend these events.
