AWARD CRITERIA AND NOMINATION RULES

- ◆ The Memorial Scholarship was established in 1972 by the Pennsylvania Credit Union Association to perpetuate the memory of all past Association Boards of Directors.
- ◆ Memorial Scholarships are awarded annually to deserving credit union professionals of any Association-affiliated credit union who wish to attend the Penn State Judge/Bradley Credit Union School.
- ◆ The Memorial Scholarship must be used to attend the School in the year in which it is awarded. The scholarship covers tuition and some additional expenses to attend the Penn State Judge/Bradley Credit Union School.
- ◆ Scholarship recipients are required to fulfill the project requirements between first and second year.
- ◆ Applicants are eligible to win this scholarship only two times.
- ◆ The questionnaire must be completed in full, signed by the applicant and the applicant's supervisor, and accompanied by a written essay (see #5). Return by ***December 31, 2009*** to: Judge/Bradley Memorial Scholarship, Pennsylvania Credit Union Association, 4309 North Front Street, Harrisburg, PA 17110-1618.
- ◆ Decisions of the Association Awards Committee will be final. Employees of the Pennsylvania Credit Union Association and its affiliates, members of their immediate families; and current members of the Board of Directors and Awards Committee, and their immediate families, are ineligible for this award.
