AWARD CRITERIA AND NOMINATION RULES

- ◆ The Volunteer Memorial Scholarship was established in 2000 by the Pennsylvania Credit Union Association to perpetuate the memory of all past Association Boards of Directors.
- ◆ A Volunteer Memorial Scholarship is awarded annually to a deserving credit union volunteer of any Association-affiliated credit union who wishes to attend the Credit Union Directors' Institute at Penn State.
- ◆ The Volunteer Memorial Scholarship must be used to attend the Credit Union Directors' Institute in the year in which it is awarded. The scholarship covers tuition only.
- ◆ The questionnaire must be completed in full, signed by the applicant and the Board Chairman or Vice Chairman, accompanied by a written essay (see #5), and returned by **December 31, 2009** to: Volunteer Memorial Scholarship, Pennsylvania Credit Union Association, 4309 North Front Street, Harrisburg, PA 17110-1618.
- ◆ Decisions of the Association Awards Committee will be final. Employees of the Pennsylvania Credit Union Association and its affiliates, members of their immediate families; and current members of the Board of Directors and Awards Committee, and members of their immediate families, are ineligible for this award.
