

## **Joseph F. Hinchey Memorial Scholarship Penn State Judge/Bradley Credit Union School**

### **AWARD CRITERIA AND NOMINATION RULES**

- ◆ The Joseph F. Hinchey Memorial Scholarship has been established by Pacul Services, Inc., a subsidiary of the Pennsylvania Credit Union Association.
- ◆ The Joseph F. Hinchey Memorial Scholarship is awarded annually to a deserving credit union professional of an Association-affiliated credit union that supports Pacul Services, Inc., through the purchase of its services.
- ◆ The Joseph F. Hinchey Memorial Scholarship must be used to attend the School in the year in which it is awarded. The scholarship covers tuition and some additional expenses to attend the Penn State Judge/Bradley Credit Union School.
- ◆ Scholarship recipients are required to fulfill the project requirements between first and second year.
- ◆ Applicants are eligible to win this scholarship only two times.
- ◆ The questionnaire must be completed in full, signed by the applicant and the applicant's supervisor, accompanied by written essay (see #5), and returned by **December 31, 2010** to: Joseph F. Hinchey Memorial Scholarship, Pennsylvania Credit Union Association, 4309 North Front Street, Harrisburg, PA 17110-1618.
- ◆ Decisions of the Association Awards Committee will be final. Employees of the Pennsylvania Credit Union Association and its affiliates, members of their immediate families; current members of the Board of Directors and Awards Committee, and members of their immediate families are ineligible for this award.



#### **JOSEPH F. HINCHEY**

Joseph F. Hinchey helped to guide the development of credit union services at the local and state level by helping to form Pacul Services, Inc., the subsidiary corporation of the Pennsylvania Credit Union Association. During his 38-year career with credit unions, Hinchey served as President/CEO of Philadelphia FCU, as chairman of Pacul Services, Inc. for 10 years, and as a member of the Association's Board of Directors for 24 years. He also served on the NCUA advisory board and CUNA's Board of Directors.
