

JOSEPHINE SAKOVICS MEMORIAL SCHOLARSHIP (Annual Convention & Expo)

AWARD CRITERIA AND NOMINATION RULES

- ◆ The Josephine Sakovics Memorial Scholarship is awarded annually by the Pennsylvania Credit Union Association. This award was established to honor Josephine Sakovics for her dedication and commitment to the credit union movement.
- ◆ Volunteers and management personnel of any Association-affiliated credit union are eligible to apply for the Sakovics Memorial Scholarship.
- ◆ The recipient of the Sakovics Memorial Scholarship will be provided with three nights' lodging, conference registration fee, and banquet ticket to the Pennsylvania Credit Union Association's Annual Convention & Expo.
- ◆ The questionnaire must be completed in full, signed by the applicant, applicant's supervisor, or the board chairman or vice chairman, and accompanied by a written essay (see #5), and returned by **December 31, 2009** to: Josephine Sakovics Memorial Scholarship, Pennsylvania Credit Union Association, 4309 North Front Street, Harrisburg, PA 17110-1618.
- ◆ Decisions of the Association Awards Committee will be final. Employees of the Pennsylvania Credit Union Association and its affiliates, members of their immediate families; current members of the Board of Directors and Awards Committee, members of their immediate families; and previous Sakovics Memorial Scholarship winners are ineligible for this award.



JOSEPHINE SAKOVICS

Josephine Sakovics dedicated more than 50 years of her life to the credit union movement. She was a charter member of The Heights St. Joseph FCU, Bethlehem, and served as its treasurer and office manager. Sakovics was a student in the first class of the Penn State Judge/Bradley Credit Union School in August, 1955. As a Board director of the Pennsylvania Credit Union Association for 30 years, she was a leading supporter of youth involvement activities. In 1968, Sakovics was the first woman to be elected as chairperson of the Board, a position she held for two years.

The Josephine Sakovics Memorial Scholarship honors her dedication and commitment to the credit union movement.
